CITY COUNCIL APPROVES AGREEMENTS designed to strengthen law
enforcement efforts in the county –
During this week's meeting the Plattsmouth City Council approved a
memorandum of understanding with the sheriff's office which would
allow the formation of the Cass County Investigations Team. Plattsmouth
Police Chief Steve Rathman explained this agreement would allow for the
activation of a team for serious crimes, instead of just having a couple of
investigators. As part of the agreement, investigators from the police
department will have the authority to respond to incidents in the
county's jurisdiction. An executive committee of the team will consist of
administrators from both the Cass County Sheriff's Office and the
Plattsmouth Police Department, with the county attorney serving as an
ex-officio member.

Approval was also given to an interlocal cooperation agreement between
the two agencies. This agreement would authorize officers with the police
department to provide law enforcement services outside of the police
jurisdictional limits of the city. Chief Rathman pointed out this will be
particularly beneficial along Highway 75 and the subdivisions that are
just outside of the police department's jurisdiction.
Mayor Paul Lambert said these agreements appear to be a win/win for
both agencies and the taxpayers.
County approval is still needed on both agreements before they go into
effect.

A MAN ARRESTED by Cass County sheriff's deputies in October 2023 was
sentenced to the Nebraska Department of Corrections this week – 28-
year-old Eric C. Becher of Aurora, Colorado is to begin serving two
concurrent two-year sentences today. If he qualifies for good time, that
equates to one year of incarceration. He had been free on bond since
two days after his arrest.
Becher had originally been charged with two Class 2A Felonies—cocaine
distribution and hallucinogenic mushroom distribution—but pled guilty to
two Class 4 Felonies for drug possession.

The arrest occurred after a traffic stop for speeding on Highway 75 near
the Platte River Bridge on October 1st of last year. Becher told the
deputy he was in the Plattsmouth area visiting friends after attending a
music festival in Arkansas.
After release from the department of corrections, Cass County District
Court Judge Micheal A. Smith ordered nine months of post release
supervision.

HERE'S WHAT IS NEXT in the Connect MoPac Trail study in Cass County
– The discovery phase was completed this spring. Now...
-Various members of the study team will be visiting the area over the
next few months. Staff from Toole Design are tentatively eying early May
for a site visit. Advance notice is to be given on visits.
-The study team may be meeting with state and county officials to
review right of way, monitor existing trail use, and see firsthand some of
the comments and observations provided during the discovery phase.
Four route alternatives will be identified later this summer.
A news release from the team says it has received several comments on
drainage and geography concerns, right of way, buffers, traffic, farm
safety, and more. Observation of these activities to understand the
source of challenges and their geographical impact, such as drainage or
flooding, may occur.


