NO IDENTIFICATION OR CAUSE YET — The deadly house fire that occurred over the weekend at Horseshoe Lake remains under investigation. The body found in the home has not been identified. ACER POSITION

Authorities told Cassgram yesterday evidence has been sent to a state pathologist for positive identification. Investigators with the state fire marshal's office also continue to work to determine the cause. Ashland Fire was paged to a fully engulfed structure fire on Fedde Lane Saturday morning just before 3 o'clock. (see Monday's Cassgram)

THE MAY 14 PRIMARY ELECTION -- For the first time, voters will need

to bring an ID in order to cast a ballot.

Some voters have requested an early ballot. Those voters were the first to provide ID by writing their driver's license or state ID number on the application. Thousands more will have to bring their ID in person.

Under the new law, you'll need to show poll workers your ID before you cast your ballot in Nebraska. The constitutional amendment was approved by voters in 2022. The Nebraska Unicameral then crafted
