ECONOMIC DEVELOPMENT STRATEGIES outlined in the mission to attract and retain businesses in Cass County — The Cass County Nebraska Economic Development Council board recently stamped approval to the following focus points for the next two years:

1. Activate key corridors through site development and targeted business attraction
2. Assess housing needs and provide a framework and resources for communities to attract and maintain housing supply
3. Prioritize the retention and expansion of existing business through consistent communication and individualized assistance
4. Build capacity and preparedness for development through community economic development workshops
5. Educate and involve the communities and region on the work of Cass County Economic Development

CCNEDC, jointly funded by public and private investors, says it is here "to provide assistance in every phase of community and economic development." CCNEDC Executive Director Josh Charvat was hired nine months ago. He said now is the time to prepare for what is expected to be a "large impact" in growth from the north and west into Cass County, and that could come as soon as a couple years from now. Decisions need to be made to provide the capacity. "Do we want to focus on the housing side of the coin, or focus on the business attraction," said Charvat.

Workforce availability, infrastructure, housing, childcare, grocery stores, restaurants, etc. are parts of the equation industries and developers consider in their decisions, so those are points CCNEDC will continue to emphasize. CCNEDC notes that Cass County has experienced steady population growth while many counties have not.

Working in Cass County's favor and the reason some of the viewings of local sites are "getting some traction right now is they are still at lower costs (than other locations) but right next to the major transportation corridors," said Charvat.

As to retaining and growing what is already here, he said CCNEDC involvement in local communities is key. "The more we know about what a community's priorities are, the more we can help out."

RESTITUTION OF \$33,000 was owed by a now 23-year-old Bennington man when he left Cass County District Court with a five-year probation sentence in June 2022 — He is now serving a 4 year to 6 year state prison sentence. The restitution was still at about \$33,000 when Bryce Warren Turnbull was sentenced for probation violation this week.

A warrant was first issued in March of 2021. The arrest warrant affidavit said the Plattsmouth Police Department was contacted by Woodhouse Ford South of Plattsmouth about an insufficient funds check to purchase a 2019 Ford Mustang. The affidavit said Turnbull had shown an app on his phone that he had approximately \$70,000 in the checking account.

That was on September 18th of 2020. He took delivery of the vehicle and wrote a personal check for \$36,386. The check later was returned for insufficient funds. Woodhouse also learned Turnbull then sold the Mustang and presented the title to another car dealer in Omaha for \$29,500. That money was deposited in a different checking account and then later transferred to different accounts, according to the affidavit.

Turnbull was booked on the warrant in May of 2021 and released on bond. The probation was given last year for the Class 2A Felony conviction of theft by deception.

Last month, the state outlined six points of probation that were violated. Among those were getting into trouble with the law for thefts, not reporting for probation visits and therapy meetings, and making only one of the \$556 monthly restitution payments ordered by the court.

Turnbull was jailed after the court hearing this week. There was credit for one day served.
