OPEN PUBLIC COMMENT TIME completed - The members of the Cass County Board of Commissioners indicated they expect to take action on the new zoning regulations packet at the March 28th meeting.
Just under 150 people attended the public hearing at the fairgrounds last night. As expected, most of the two hours of public comments revolved around commercial solar. The proposed regulations recommended by the county planning commission have a solar section that allows for commercial solar in agriculture and transitional agriculture zoned areas. The recommended setbacks from houses are 150 feet in ag zoning and 300 feet in transitional ag. Judging from the public input and the board members' questions and comments, two decisions that appear to face the county board are whether to allow commercial solar conversion systems in trans ag and whether the setbacks should remain as proposed. Commissioners may also look at increasing fees for a solar farm application.
The Cass County Solar Project by NEXtera Energy north of Murray is waiting until the regulations are in place before submitting a formal application for a conditional use permit. That consideration process then would require another round of public hearings. The county board has the final say and the authority to modify regulations in issuing a permit.

COURTHOUSE DOORS TO REOPEN - The public will be able to use the doors to the landings between the first and second floors of the Cass County Courthouse for the first time in nearly three years. Only emergency exits had been allowed through those west side and south side doors. The Cass County Board of Commissioners voted 5 to 0 to allow normal entrance and exit.
Covid-19 was the driving factor in limiting entrances and exits only to the west door on level 1. At one point after the courthouse re-opened in June of 2020, courthouse security took forehead temperature readings of those entering.
A guard remained at the door once the major Covid 19 threat subsided. Courthouse security was also a factor in keeping one access point.
District 1 Commissioner Dale Sharp brought forth the idea of the full reopening on February 14th. Commissioners discussed it again at the February 28th meeting. Sharp asked that it be on this week's agenda.
Courthouse department representatives were asked for their input. County board chairman Duane Murdoch said the results showed eight responses were in favor of the full opening, seven preferred the one door restriction.
The board discussions formed the consensus that the courthouse will continue to have a fulltime sheriff's deputy on the premises that will roam the courthouse and the adjoining annex facility.
The other commissioners agreed with Sharp's suggestion that training be initiated so that employees learn what to do in active shooter or terroristic threat situations.

FIRE CALLS late in the afternoon Tuesday - Units from the Louisville and Plattsmouth fire departments used their rural equipment to extinguish a brush fire in the 8500 block of Ashland Road. Shortly after that incident, Louisville answered a mutual aid call from the Springfield department for help with a field fire east of Highway 50 near Buffalo Road in Sarpy County.

PLATTSMOUTH SPRING CLEAN-UP is scheduled for Saturday and Sunday, May 6-7 from 8am to 6pm at the east end of Main Street past the railroad tracks - Plattsmouth residents and property owners may drop off items free of charge, but non-residents and trucks greater than one ton are required to pay a fee in cash.
