RESIGNATION FROM SCHOOL BOARD - Matt Glup submitted his resignation from the Plattsmouth Board of Education during a meeting this week. He will no longer be residing in the district.
 In a letter to the board of education Glup stated he feels the board has made great progress in many areas. Glup had served on the board for over 19 years. His current term is set to expire in December. It is the Board's goal to have an applicant approved by their April meeting. The board will have 45 days to fill the vacancy.

COUNTY PLANNING COMMISSION actions at the March meeting - The commission reorganized and it recommended approval of a new extraterritorial jurisdiction (ETJ) zoning map for the Village of Murray.
 ---The vote was unanimous on the following officers for 2024:

 ---The (draft) minutes show planning commission members were told by the zoning administrator that Murray's proposed change from "a radial ETJ to a property line ETJ is generally considered a best practice."
 Jeff Anderson, Murray Board of Trustees Chairperson, stated the village leadership expects a lot of growth for the community as a result of the 4-lane expansion on Highway 75 and that changing the ETJ would make it a lot easier for potential growth.
 Commission members were told any non-conforming properties that already exist will not be affected, but new construction or major rebuild projects in the new ETJ will fall under the zoning rules and regulations.

THEFT CHARGE REDUCED from a felony to a misdemeanor - The plea agreement between the prosecution and defense states the 38-year-old La Vista man will get a recommendation for a fine if he makes the \$4,000 restitution before sentencing in June. He already has some funds saved, but if he falls short of full repayment the recommendation will be probation with a restitution order.
 Scott A. Dodenhof was originally charged with a Class 4 Felony for taking cash from an envelope in his employer's truck at a work site in the Beaver Lake area. The cash was for a load of concrete that was being delivered to the job site.
