SOLAR COMPANY is the appellant, petitioner, in a case now active in Cass County District Court – Named as appellees, respondents: The Board of Commissioners, Cass County, and Cass County.

Cass County Solar Nebraska, LLC submitted the filing on March 12th.

In a 4-0-1 vote on February 11th, the board of commissioners denied the conditional use permit (CUP) application of Cass County Solar for a 265 MW commercial solar conversion system (CSCS) north and west of Murray.

The solar company, a subsidiary of NextEra Energy, is requesting "a trial de novo to allow the Court to objectively measure the extensive evidence in support of the Solar Farm and approve the Permit Application."
The court filing states the CUP application complied with county zoning regulations, adding "...Cass County Solar did not request any variances or special exceptions" in the application. It notes landowners voluntarily leased their land for the CSCS. The four year history of the application is reviewed.
The court filing says the solar farm "would have brought significant economic development and tax revenue to the community." That information given at a county public hearing (Cassgram Archives 12/30/24) is in the filling.
The court document states the board of commissioners' decision
"erroneously concluded that the Solar Farm would interfere with existing agricultural uses and was not in accordance with the Cass County
Comprehensive Plan." In support, the filing states the solar farm would occupy about .47% of the county's 299,000 acres in agriculture use.
Other entries in the case filed at this time are for requests of county materials and recordings from the application process.

There is no reply yet from the county. Cassgram will bring the county's response when that occurs.
One of the items on the county board meeting agenda today: "6C. Executive session- Personnel Matters and pending legal actions."
