SOLAR COMPANY is the appellant, petitioner, in a case now active in Cass County District Court – Named as appellees, respondents: The Board of Commissioners, Cass County, and Cass County.  
 Cass County Solar Nebraska, LLC submitted the filing on March 12th. In a 4-0-1 vote on February 11th, the board of commissioners denied the conditional use permit (CUP) application of Cass County Solar for a 265 MW commercial solar conversion system (CSCS) north and west of Murray. (Cassgram Archives 2/12/25)  
 The solar company, a subsidiary of NextEra Energy, is requesting "a trial de novo to allow the Court to objectively measure the extensive evidence in support of the Solar Farm and approve the Permit Application."  
 The court filing states the CUP application complied with county zoning regulations, adding "...Cass County Solar did not request any variances or special exceptions" in the application. It notes landowners voluntarily leased their land for the CSCS. The four year history of the application is reviewed.  
 The court filing says the solar farm "would have brought significant economic development and tax revenue to the community." That information given at a county public hearing (Cassgram Archives 12/30/24) is in the filing.  
 The court document states the board of commissioners' decision "erroneously concluded that the Solar Farm would interfere with existing agricultural uses and was not in accordance with the Cass County Comprehensive Plan." In support, the filing states the solar farm would occupy about .47% of the county's 299,000 acres in agriculture use.  
 Other entries in the case filed at this time are for requests of county materials and recordings from the application process.  
 There is no reply yet from the county. Cassgram will bring the county's response when that occurs.  
 One of the items on the county board meeting agenda today: "6C. Executive session- Personnel Matters and pending legal actions."  
 ---In the trial de novo (new trial) process, the court would review the case based on applicable legal standards and zoning laws, rather than relying on the previous decision made by the county board.

**ROBBERY SUSPECT** - A 62-year-old Plattsmouth man is in custody following an investigation in Omaha. The Douglas County Sheriff's Office reports Dale Woita was arrested Thursday and booked into Douglas County Corrections. He is suspected in the March 15 robbery at Hy-Vee Fast & Fresh near 203rd and Vinton. Witnesses say an older man wearing a surgical mask claimed to have a weapon and demanded money.  
 Investigators identified Woita through video evidence. He was taken into custody near Highway 370 and 25th Street.  
 Omaha Police also linked him to the March 1 robbery at Cobalt Credit Union near 204th and Pacific. In that case, the suspect used a note to demand cash. Authorities are continuing the investigation.

**TWO DUI BOOKINGS SATURDAY NIGHT** - Cass County sheriff's deputies made two DUI arrests within an hour.  
 A black BMW was stopped on Highway 34 at the Highway 43 intersection. A 19-year-old Omaha man was booked for DUI. Additional citations: reckless driving, marijuana possession (less than one ounce).  
 Deputies responded to a report of a person slumped over the wheel of a red Ford F150 on East Union Drive off Highway 75. A 31-year-old Omaha man was arrested. Booking information notes a pending charge of refusal to submit to DUI testing.

**FIELD FIRE** in the area of Wiles Road and Vireo Parkway Monday afternoon - It took about 90 minutes for Plattsmouth and Murray departments to extinguish the fire spread started by construction work. Railroad traffic was halted while fire crews worked.
