MULTIPLE DEPARTMENTS BATTLE separate grass fires Wednesday — The first was a controlled burn that started spreading at noon in the area of Murray Road and 27th Avenue. southeast of Beaver Lake. Murray, Nehawka and Plattsmouth fire departments responded. The fire was declared extinguished around 2:30pm.

Before Murray crews could clear from the scene of that fire, a report was received of a field and tractor fire at 7305 12th Avenue. The initial page stated the flames were approaching a nearby residence. Weeping Water and Avoca fire departments were requested for mutual aid. The landowner was assessed at the scene by rescue but refused treatment. Crews were on the scene of the fire on 12th Avenue for two hours.

VILLAGE OF MURRAY ZONING NEWS — ▶The Cass County Board of Commissioners approved the Village of Murray's request to change its one-mile extra territorial jurisdiction (ETJ) from a radius to parcel line jurisdiction. Eagle, Elmwood and Plattsmouth have this same type of ETJ alignment. The Village of Murray and the Cass County Planning Commission unanimously approved the requested change in previous actions of each body.

During the county board meeting this week, the Chairman for the Murray Village Board of Trustees, Jeff Anderson, stated the change is designed to make things simpler by eliminating the possibility of two different jurisdictions going through a parcel. Anderson added the village did not incorporate any new parcels but may have extended the line to include an entire parcel. Two public meetings were held on the proposed change to the ETJ. Anderson stated there were more questions than opposition. District 5 Commissioner Duane Murdoch's motion to deny the request failed due to a lack of a second. A motion to approve the request then passed four to one, with Murdoch the only vote in opposition.

The Murray village board approved a telecommunications tower placement earlier this year. The US Cellular special use permit application was within the Murray ETJ at 606 Murray Road.

Per village board minutes, the application was for a tower with a tip height of 194 feet and for the related equipment at the base.

The village board motion approving the request found the "use is compatible with and similar to the use permitted in the district, does not

CAMPAIGN SIGN PLACEMENT RULES - The Nebraska Department of CAMPAIGN SIGN PLACEMENT RULES — The Nebraska Department of Transportation is reminding the public that it is unlawful to place political campaign signs, or any signs, on state highway and interstate right-of-way. This includes intersections, medians, entrance and exit ramps, sidewalks, the ditches and lands that make up the right-of-way bordering the length of each roadway.

NDOT maintenance crews will remove any signs that are improperly placed within the state highway right-of-way. These signs will be stored for a brief time in the maintenance yards throughout the state where the owners may reclaim them.

Additional regulations governing political campaign sign placement and size are sometimes set by each county and/or municipality. The public is advised to reference local regulations for questions regarding a specific ocation and to keep in mind that violation of local sign ordinances may esult in a fine.

Cass County Superintendent of Roads Lenny Thorne said signs collected by his department will be taken to either the shop in Weeping Water or Mynard. Thorne said so far county crews have picked up very few signs.
