

PUBLIC NOTICE - Cass County Weed Control Authority 402-234-4104 PROJECT NOTICE Section 2-965, Re-issure Revised Statues of Nebraska, provides a county weed control authority may direct and carry out projects of control for one or more specific noxious weeds without individual notice as prescribed in section 2 -955 if the control authority has caused publication of noticed of such project. The Cass County Weed Control Authority will be doing control work on selected sites of Purple Loosestrife, Phragmites & Saltcedar as part of the Lower Platte Weed Management Area along the Platte & Missouri Rivers and their tributaries, also sites of Phragmites in upland areas. Control work will be performed from June 5 through December 30, 2024. The control work will be provided at no cost to the landowners of these sites. Landowners of sites not selected will be expected to control these noxious weeds on their properties with control work that is approved by the county weed control authority. Landowners should contact their county weed control authority if they have any questions or would like assistance in arranging for control of these and other invasive weeds on their properties.
