FELONY CHARGES FILED after county attorney review of police reports - The incident was in the early morning hours last Thursday on South 9th Street in Plattsmouth.
Police broadcasts advised of an incident that involved at least three adults. Two children were in the residence. Law enforcement officers were also advised there was a shotgun at the location, but it had not been discharged. (Thursday Cassgram 6/6/24) The police affidavit said two friends arrived at the location after a phone call from a female at the residence. The affidavit said an officer drew his rifle while another officer made the arrest, taking the suspect to the ground. A loaded shotgun was confiscated.

Cass County Court filings show 23-year-old Alexander M. Kaffenberger is charged with three counts of terroristic threats, a Class 3 Felony, and one count of use of a weapon to commit a felony, a Class 1C Felony.
In a court hearing on Zoom yesterday, Cass County Court Judge David Partsch found there was probable cause for detention and set bond at \$100,000 (10% applicable.) No contact orders were placed in effect for three individuals if the defendant is released on bond. The preliminary hearing is set for July 2nd.

ARREST DURING DISTURBANCE - Plattsmouth police responded to the 900 block of 2nd Avenue yesterday just before 6pm for a report of an intoxicated male that was fighting with others in the home, while children were present. A 20-year-old Plattsmouth man was taken into custody for an alleged probation violation.

NO INJURIES FROM ACCIDENT - Authorities were advised of a two vehicle accident involving a dump truck yesterday shortly after 3:30pm at northbound Highway 75 just south of East Wiles Road. The first deputy on location requested Plattsmouth EMS and fire respond for a subject complaining of rib pain. Subject was evaluated on scene and declined transport to a hospital.

The Cass County Weed Control Authority will be doing control work on selected sites of Purple Loosestrife, Phragmites & Saltcedar as part of the Lower Platte Weed Management Area along the Platte & Missouri Rivers and their tributaries, also sites of Phragmites in upland areas. Control work will be performed from June 5 through December 30, 2024. The control work will be provided at no cost to the landowners of these sites. Landowners of sites not selected will be expected to control these noxious weeds on their properties with control work that is approved by the county weed control authority. Landowners should contact their county weed control authority if they have any questions or would like assistance in arranging for control of these and other invasive weeds on their properties.
