PLEA AGREEMENT REACHED IN THEFT CASE — 40-year-old Sasha Reichenberg of Lincoln was accused of using her power of attorney

Reichenberg of Lincoln was accused of using her power of attorney to withdraw money from her father's bank account. Cass County Attorney Chris Perrone told the court Reichenberg was using the money to support her gambling problem.

As part of the agreement, she entered a plea of guilty to charges of abuse of a vulnerable adult, a Class IIIA felony, and theft by taking in the amount of \$5,000 or more, a Class IIA felony. The state agreed to dismiss two other charges. There is no agreement regarding the sentence to be imposed. There is no agreement regarding the sentence to be imposed. The state and defense agreed to restitution totaling \$77,905 for both cases.

Sentencing is scheduled for September 23rd.

MONTHLY ECONOMIC REPORTS — The latest retail sales tax reports returned mixed numbers for April. State labor department data

showed an increase in the unemployment rate.

In comparing April of 2024 to April of 2023, the Nebraska
Department of Revenue's Net Taxable Sales Report shows Cass County with a 5.1% decrease to \$12,633,407. In Plattsmouth, April sales were up 2.3% to \$6,458,918.

(In the March 2024 report, Cass County sales were down 6.8% and

Plattsmouth sales were down 5.5%.)

Statewide, April 2024 sales were up 1.0% from the same month of PLAY OUR NTS MACHINES the previous year.

The April comparison for neighboring counties: Otoe -4.5%, Lancaster +1.4%, Saunders +2.8%, Sarpy -3.8%.

Nearby cities: Ashland -0.4%, Bellevue +0.3%, Nebraska City -2.3%, Papillion -10.6%, Springfield +39.5%, Syracuse -6.8% and Waverly +13.5%.

The NDR's Net Taxable Motor Vehicle Sales Tax Collections Report

At Subway in Plattsmouth said the 5.5% sales tax total in Cass County went from \$431,391 in April 2023 up to \$536,202 in April 2024.

The net taxable amount subject to sales tax collection in Cass this past April was \$9,730,500, up 24.2%.

Statewide the net taxable motor vehicle sales total was up 8.4%

compared to a year ago.

(The motor vehicle sales tax is paid in the county where the vehicle is registered, it may not have been bought in the county.)
▶The Cass County unemployment rate for July 2024 was 3.4%, up from 2.4% in June. Surrounding counties also posted higher rates.
The state unemployment rate was 3.1%, up from 2.6% in June.



STATEMENT OF PRINCIPLES' issued yesterday by Nebraska Governor Jim Pillen – The news release was issued as the special session of the Nebraska Legislature begins this week. The session will deal with property taxes.

"This legislative process depends on everyone bringing their good faith ideas for the purpose of producing property tax reform for all Nebraskans," said Gov. Pillen. "It is important that we start from a common place of understanding, especially in the debate over sales tax exemptions."

Gov. Pillen's statement of principles follows:
• No sales tax on food

- No sales tax on medicines used for human treatment
- No taxing services or goods provided through nonprofits

 No sales tax on ag inputs or manufacturing materials (defined as physical economic resources used to create goods to be sold to an end user)
- No sales tax on services or items that are exempt in all other states No sales tax on services or items that are exempt in all surrounding states

No double taxation
 "I think these principles will help provide clarity and structure to what we need to consider when it comes to that long list of exemptions that are in play," said Pillen.
