NO FIRE INCIDENTS over the weekend, but volunteer rescue departments and the paid staff rescue departments were a bit busier than usual with rescue calls — In the 24-hour periods (5am to 4:59am) countywide: Friday-9 calls, Saturday-7 calls, Sunday-7 calls.

The dispatch advised of a 51-year-old woman who was thrown from a horse about 10am in the 7000 block of 132nd Street. The patient was taken to Bergan Mercy Hospital by Weeping Water rescue.

Plattsmouth EMS and fire units, and Murray rescue, were sent to 42nd Street south of Highway 66 at 7:40pm for a woman injured in a UTV accident, two others were checked out at the scene.

A news release was issued on this incident. Cass County Sheriff Wm. C. Brueggemann said the driver was Petra Luteran, age 25, Omaha, and the passengers were Brock Milius, age 23, Omaha, and Connor Voigtman, age 23, Plattsmouth. The UTV was traveling north on 42nd Street and turned onto a gravel driveway, went out of control and rolled onto the driver's side, ejecting all three. Luteran was transported to the downtown Omaha trauma center with serious injuries. Brueggemann said alcohol was a factor. The use of an UTV on the roadway and speed are factors in the investigation.

Seatbelts were not in use, said the report.


