CITY COUNCIL DENIES conditional use permit — The request was from Ben Katt of Wet Water, LLC for an event center at 37075 N Timber Ridge Drive in the Timber Ridge Subdivision. Per the (pending) September meeting minutes, the Louisville mayor and council were told Katt family members wanted to rent out the home for small events, such as weddings, family reunions, etc. It is a gated community. The Timber Ridge Subdivision homeowners association presented a list of concerns. Several neighbors spoke against it. The council vote to deny was 4 to 0.

DEFENSE SUGGESTS PROBATION NOT BE GIVEN after it was apparent no jail time was likely — It was a Cass County District Court case. The defendant had been growing marijuana at his residence. A police investigation led to the original charge that was a felony. The plea agreement resulted in guilty pleas to Class 1 and Class 3 misdemeanors. The prosecution started the sentencing hearing by saying it would not object to probation. The defense then presented its recommendations to District Judge Michael A. Smith.

The defense counsel said her client openly acknowledged he has used marijuana for a long time and that there was no evidence that the marijuana was being sold. Describing her client as a "prolific gardener" of vegetables for his own use, Julie Bear said the growing of marijuana "wasn't any different in the respect he was growing for his own use." Bear said it was her personal thoughts in asking, "Do we really gain anything by placing him on probation?" She noted many states are decriminalizing marijuana. She asked the judge to consider a sentence of time served and a maximum fine. Cass County Attorney Chris Perrone spoke up and said if the court was considering not placing the defendant on probation he would like to be heard again. Judge Smith responded, "I do intend to put him on probation." 57-year-old Rodney Adkins of Plattsmouth was placed on probation for 12 months. Illegal drug use would be a probation violation. Among the other terms of probation: -allowing testing for drug or alcohol use as requested -allowing a search of person, property or vehicle upon order of the probation officer.

FIRE CALLS on Wednesday — Plattsmouth units were sent to the 1200 block of Clinton Street for a carbon monoxide alert. Eagle fire was sent (twice) to a controlled burn on A Street that crept out of control toward a field.
